#### SMALL BUSINESS WHAT DO WE DO?

#### **Small Business Development Program**

- Provide opportunities for local small businesses to participate in contracting and procurement at Port Houston with 35% overall SB goal.
- Outreach Activities
- Business-to-Business Connections
- Industry Specific Forums
- Training & Development Initiatives
  - Port University
  - Inter-Agency Mentor Protégé Program





#### SMALL BUSINESS ENROLLMENT

- Businesses must meet certain criteria and be certified with one of Port Houston's partner agencies
- Applies to all contracts over \$50,000
- Race-and gender-neutral program
- Restricted to local small businesses within the 8 counties surrounding Houston (Harris, Montgomery, Waller, Brazoria, Ft. Bend, Galveston, Chambers, Liberty)
- The size of the business must not exceed Code of Federal Regulations 49 CFR §26.67 or 13 CFR §124 for small business owners. Visit www.sba. gov/size for more information.
- Net worth of the owner must be less than \$1.32 million, excluding the owner's primary homestead and assets of the business.

Participation Requirement / Small Business Requirements:

- <u>Project #1</u> Concrete Pavement Replacement at Barbours Cut and Bayport Terminals – 2021, CSB, SB 20%
- <u>Project #2</u> Fender System Maintenance at Barbours Cut and Bayport Container Terminals – 2021, CSB, SB 20%
- <u>Project #3</u> Crane and RTG Crane Painting at Bayport and Barbours Cut Terminal 2021, CSP, Exempt from SBDP, 0% SB participation
- <u>Project #4</u> Concrete Pavement Replacement at Turning Basin Terminal 2021, CSB, SB 20%
- <u>Project #5</u> Splash Zone Painting at Turning Basin Terminal 2021, CSP, SB 25% pass/fail

Bidder who fails to meet the minimum requirement will be considered non-responsive and will not be evaluated.

- This project will consist of surface preparation, repair and replacement of various fender system elements at Barbours Cut and Bayport Terminals.
- Fender system elements include safety nets, timbers, cross chains, bolts and shackles.


**Project # 3 -** Wharf Crane and RTG Crane Painting at Bayport and Barbours Cut Container Terminals
